HELMET TAGGING





Standards as at December 11, 2024

TAG PLACEMENT

Wrap the helmet "tag" around the harness, high up, on the left hand side so it is visible, but out of the way.

HELMET STANDARDS ARE USUALLY FOUND IN THE HELMET'S LINING:

- o on an info tag;
- o direct onto the lining;
- o or on a sticker.

Helmets must conform to one of the current approved safety standards:

HELMET TAGGING INSTRUCTIONS AND TIPS

- Check all helmets carefully to find the standard/s. There may be more than one and they may not be together. You may need to remove the lining to find the standard/s. It will be either on a sticker on the inside shell, on the outside of the shell or directly on the liner (the liner may be removable and the standard is usually on an information tag attached to the liner).
- The symbols/marks are Quality Assurance Marks and signify that the helmet has undergone extra safety testing they are not mandatory, the main thing to look for is the Standard itself, the marks are just an extra.
- The years that are associated with applicable standards are not the year of manufacture for that helmet, but the year the helmet standard was released, superseding the previous standard.
- More than one standard is fine, provided one of them is a compliant standard. Familiarise yourself with our accepted safety standards on the EA website at <u>https://www.equestrian.org.au/content/current-approved-safety-standardshelmets</u>
- When a standard has a year attached to it (eg AS/NZS 3838 2006) the year refers to the date the Standard came out (or was published), not the year of helmet manufacture – so anything from that standard year onwards is compliant.
- We will accept helmets with standard ASTM F1163 (2004a or 04a onwards) provided they are SEI marked. Remember, AS/NZS 3838 (2006 onwards) is compliant provided they are SAI Global marked.
- Wrap the helmet tag around the harness so it can be easily seen by an
 official/steward from the ground (see picture for preferred placement). Make sure
 you are out of any wet/rain as they don't seem to stick very well if not dry.
